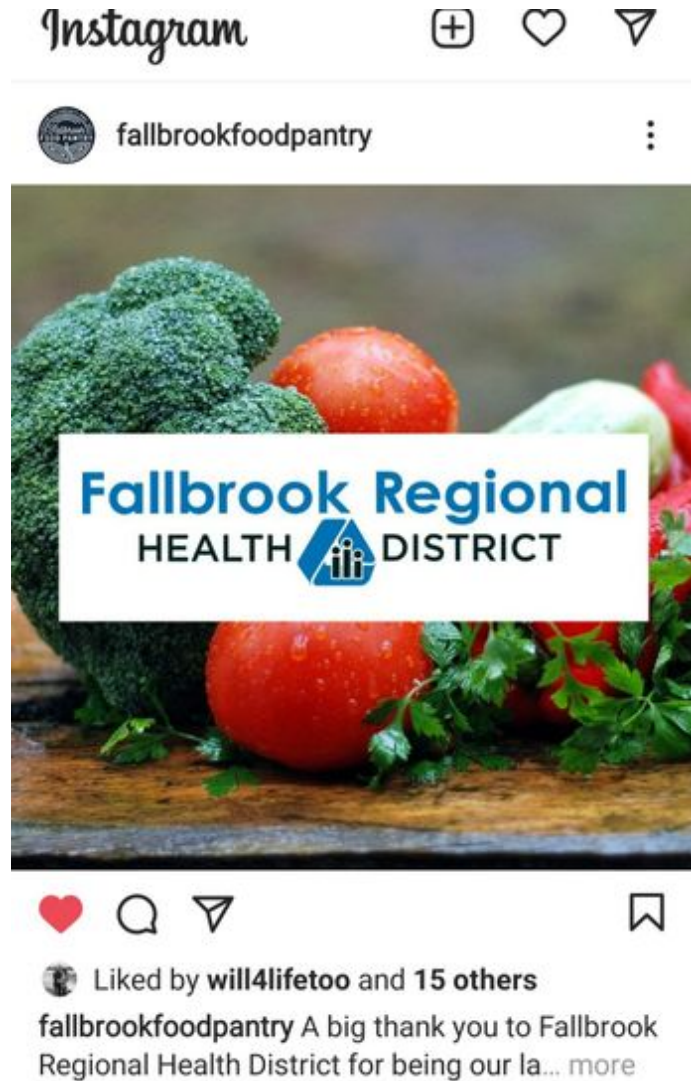

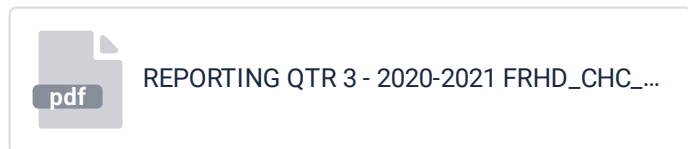

### **MEET SHONDRA**

Shondra is a 62-year-old grandmother raising her two grandchildren after her daughter died several years ago. When Shondra received custody of her grandson, Michael now 9 and granddaughter, Shilo now 7, she was working two jobs to support herself and her husband who has chronic COPD and has not been able to work for the last eight-years. Working 60+ hours every week she wasn't sure how she was going to be able to take care of her grandchildren, but a social worker guided her through the process explaining that she qualified for a variety of government programs that help grandparents who are now raising their grandchildren. Shondra applied for as many programs as she could qualify for and when she realized that she will still have to work at least one job for another 6 or 8 years, she came to the Pantry asking if she qualified for food assistance. Our Case Manager worked with her and discovered that with just her income, alone, for four people, she exceeded the Federal Guidelines of Poverty and Shondra was able to keep feeding her entire family without having to suffer or go without. Shondra has been a client of the Fallbrook Food Pantry for nearly 3 years.
