### **Program Objectives**

Objective 1: Improve family functioning and decrease family stress by providing customized case management services and parent coaching.

Objective 2: Decrease social isolation and increase connection to a community of supports by providing monthly support groups and quarterly educational workshops.

Objective 3: Provide effective case management and support services that meet the needs of grandfamilies and their grandchildren, in order to create an environment where the full potential for health and well-being can be met.

#### **Program Outcomes/Measurables**

Objective 1: Q1 - 18 grandparents have been connected to over 52 community resources and received guidance and coaching over the first quarter. Community resources for food, health and wellness, and recreation options were the most requested and received. Self-report surveys will be sent in January.

Objective 2: Q1 - Five grandparents participated in at least one monthly support group – three participated in all three. Eight grandparents participated in the July Legal Issues workshop and 6 grandfamilies attended the family night event in September. The response to the Legal Issues workshop was overwhelmingly positive. Grandparents requested more info on legal issues and also training in parenting and technology.

Objective 3: Q1 - Satisfaction surveys will be sent in November and April.
