## GOALS & OBJECTIVES

### **Goal 1 & Objectives: From your application, please provide your measurable outcomes for each of your stated objectives.**

By June 30, 2021 Champions for Health will provide a flu vaccine to at minimum 250 residents of the Fallbrook Regional Health District.

During Q3, CFH vaccinated 3 individuals for the Flu, on 1/13 for a total 329 FRHD residents vaccinated for the Flu. Attention at the County of San Diego (our vaccine partner) shifted to COVID as availability of the vaccine allowed. Seven COVID vaccination events occurred in FRHD during Q3 in Fallbrook, DeLuz and Rainbow, and 1,343 doses have been administered for COVID-19: 650 first time doses, 174 second time doses, and 236 Janssen doses, for a total of 886 residents. There are 596 pending Moderna 2nd doses, and 586 farmworkers at 10 nursery sites interested in the vaccine and pending scheduling.

#### Objective 1

Confirm existing FRHD partner sites to implement FY 20-21 flu vaccine.

-More than 10 sites have been identified to implement Flu and COVID vaccine.

#### Objective 2

Respond to new requests for flu clinics from potential FRHD partners.

-CFH has partnered with school sites, senior care facilities and other congregate spaces, and farm and nursery sites to implement the COVID 19 vaccine.

#### Objective 3

Identify low-access and low immunization locations to outreach to such as nurseries, trailer parks, and faith-based locations.

-CFH has partnered with school sites, senior care facilities and other congregate spaces, and farm and nursery sites to implement the COVID 19 vaccine.

### **Goal 2 & Objectives: From your application, please provide your measurable outcomes for each of your stated objectives.**

By June 30, 2021, Champions for Health will serve 50 youth ages 7-17 through the Vaccine for Children program.

78 youth have been served in FRHD, although not through the VFC program - which was postponed this year due to COVID-19 restrictions. In Q2 5 youth were served, but we are awaiting additional data for the end of March to be processed - we will be reporting updated numbers and anticipate serving more youth in Q4.

#### Objective 1

Confirm existing FRHD VFC partner sites to implement FY-20-21flu vaccine.  
-Additional COVID 19 events have been held in school and community settings. As the vaccine becomes more available to youth, we will report on additional sites.

#### Objective 2

Respond to new requests for VFC clinics from potential FRHD school sites.  
-Events have been implemented at 4 school sites.

Implement VFC clinics at FRHD school sites.  
-Events have been implemented at 4 school sites.

## **PARTICIPANT SUCCESS STORY**

### **Participant Success Story:**

One of our success stories this quarter was working with community group VOCES de Fallbrook, Vista Community Clinic, and others who supported De Luz resident Maricela to create a linkage to neighboring agricultural workers at Farm ACW in De Luz to vaccinate 142 farmworkers and their family members for their first dose of Moderna.

Fallbrook Regional Health District's investment in vaccinations has allowed us to focus on a rural area that would not have otherwise received similar attention without its support, and highlight these needs to the County. While Fallbrook's zip code falls within the State of California's Health Equity zip codes, it is not part of Live Well San Diego's Health Equity catchment - something CFH will be able to change and impact due to the data collected and needs shown through our collaboration.

"Thank God I felt lighter, I feel more sure of myself, that I can protect my community - in reality it's very important we all get the vaccine to protect each others, our families, and ourselves. Vaccinations are Life." -Maricela, organizer, De Luz resident

"It went well - I came to get the vaccine - the first of two doses. Everything came out well, I also invite everyone to not have fear and to get their vaccine for their families, and everyone." - Joel, Agricultural Worker

"I came to get the vaccine - it was really fast and I feel very well. I would encourage everybody to get this vaccine because it's needed." - Angel, Agricultural Worker

"We're here getting the vaccine because this disease is very current and urgent and we have to be prepared, this could be helpful and may avoid hospitalizations. I'm going to bring my family so they can get it too. It's recommended to get it - it's everyone's personal decision, but one I hope we all take to get this vaccine" - Ruben, Agricultural Worker

"I work here and we came for the first. It didn't take long - 15 minutes to check for symptoms and everything is great" - Jose, Agricultural Worker

"Thank you for coming to give the vaccine, and everyone come get the vaccine, get it, don't be afraid - it's medicine, and if we all cooperate, science advances." - Samuel, Agricultural Worker

"It went well. I feel happy, because this is a great step we are taking for all humanity, we will have the liberty to be able to get out more, and still use our masks all the time - which is the most important thing." - Victor, Agricultural Worker

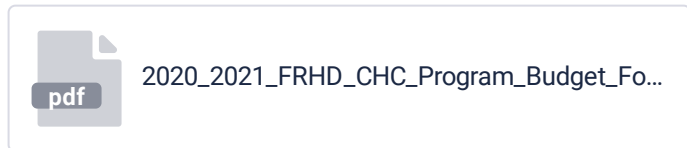
